Terms and Conditions

A. Order

This constitutes an order for photography services by KJS. It is understood that all proofs, negatives, digital files, and sample prints remain the property of KJS and they may be used for advertising, display in any media, or any purpose deemed appropriate by KJS.

B. Fees

KJS will provide photography coverage on the CLIENTS above wedding day for a fee of \$XXX. This fee will include XXX hours of photography coverage. If additional coverage is required KJS will charge the CLIENTS an additional \$150 per hour fee charged in one-hour increments.

Unless otherwise requested in writing, the CLIENTS wedding will be exclusively photographed using professional _____ SLR cameras. If the CLIENTS request large format, medium format film, KJS will charge an additional fee of \$50 per roll for film purchasing and processing and \$20 per sheet if large format is requested for film purchasing and processing.

E. Exclusive Photographer

KJS shall be the exclusive photographer retained by the CLIENTS for the purpose of photographing the wedding specified herein. Family and friends of the CLIENTS are permitted to photograph the wedding and all other photographic sittings specified herein as long as they shall not interfere with KJS duties and do not photograph poses arranged by KJS.

F. Liability

1. Although all care will be taken with the images taken at the wedding, the photographer and KJS limits any liability for loss, damage or failure to deliver images for any reason to return all fees paid to KJS to the CLIENTS. In addition, KJS or the photographer, will not be held liable in the event of fire, strike, casualty, act of God, or other cause beyond the control of the parties, or due to KJS or the photographers illness, then KJS shall return all received fees paid to KJS to the CLIENTS but, shall have no further liability with respect to the Agreement.
2. The photographer or KJS will not be held liable in the event of environmental conditions beyond its control and reserves the right to decline photography outdoors in inclement weather. The CLIENTS are responsible for an alternate location for any photographic services.
3. Although back-up equipment for most essential items is carried, the photographer or KJS is not liable for damages, including but not limited to delay or omission arising from inherent equipment defects or fault, or other causes beyond its control. Liability in any event is limited to refund of all photographer fees paid.

G. Damage to Equipment

In the event any of the Photographers equipment is stolen, damaged or destroyed, either accidentally or intentionally, by the CLIENTS, wedding guest, attendants or employees of the CLIENTS, the CLIENTS are fully responsible for the equipments replacement at current new market prices.

H. Reservation

In order to reserve the date you requested, a booking fee of \$_____ is required. KJS cannot reserve this date until the fee is received. Upon signature, KJS reserves the time and date agreed upon, and will not make other reservation for that time and date. For this reason all reservation fees are non-refundable unless written notice is given 120 days prior to the wedding date. The remaining balance is due upon delivery of the Deliverables.

This agreement may be changed only by an agreement in writing between KJS and the CLIENTS. This agreement contains the entire agreement of the parties. The laws of the state of California shall govern this agreement.
